



COLORADO PRESIDENTS CUP

RULES AND PROCEDURES

2009/2010 Series

I. PURPOSE OF THE COMPETITION

The US Youth Soccer Presidents Cup provides a progressive, competitive experience to US Youth Soccer teams from the state to regional to national level. **The Presidents Cup gives Under-14 through Under-17 age groups who play Premier 2 or below divisions an additional opportunity to compete against teams from across the country at a high level for the joy and challenge of the game. It provides the chance to experience a unique US Youth Soccer event with camaraderie, community and competition through the sport. In Colorado, Under-13 teams gain the same opportunity at the State level.**

II. AUTHORITIES AND RESPONSIBILITIES

- A.** The following Specific Rules shall apply to all US Youth Soccer Presidents Cup games.
- B.** The authority for approval of dates of the competition shall be vested in the Board of Directors of CYS.
- C.** State, Regional and National Presidents Cup Competitions shall take precedence over all other games, whether they are league or tournament play, including out of state play.
- D.** The entrance fees for this competition shall be established and approved by the CYS Board of Directors.

III. TEAM ELIGIBILITY

- A.** US Youth National Presidents Cup shall be open to any age appropriate youth soccer team that is duly registered with CYS, providing that such team is in good standing. The competition shall not be open to "select teams".
- B.** All players shall be registered with CYS affiliated clubs and teams. Coaches, team representatives and chaperones will possess a current KIDsafe background check.
- C.** The team roster for CYS Presidents Cup and all levels of Presidents Cup Competition for which the team qualifies, shall be the team league roster at the time the roster is frozen.

- D.** Roster changes will comply with current CYS rules and Regulations addressing player transfers. The team roster for this competition shall be frozen no later than 9 calendar days (at the close of business) prior to the first scheduled Presidents Cup game.
- E.** For U-15 and younger teams, the team roster shall not have more than 18 youth players on the team roster at any given time during the seasonal year.
- F.** For U16 and older teams, the roster may have up to 22 youth players on the team roster at any given time during the seasonal year.
- G.** For teams to advance to National competition, rosters will have continuity that includes at least 65% + 1 of the players who participated in the Regional Qualifiers for Presidents Cup.
- H.** No player added to a team during the seasonal year shall be rostered to a US Youth Soccer National Championship Series team in the same year.
- I.** Every team roster shall have a minimum of 7 players on the roster at all times.
- J.** For those teams utilizing the 22 man roster, only 18 players may be suited up in game day uniforms to play at any given game. The team may allow the remaining 4 players to sit on the bench provided that they are not suited up in game day uniforms. These players are subject to the Laws of The Game.
- K.** Any team utilizing the 22 man roster must inform the game assigned game day referee as to which players will be participating in their upcoming match. The Referee shall check off those players not participating in each match.

IV. TEAM CREDENTIALS

- A.** By entering the US Youth National Soccer Championship Series, each team agrees to appear for and to compete in every scheduled match for whom it qualifies, including any and all Regional and National Championship matches. Each team also agrees to assume full responsibility for the financial and travel requirements associated with competition at the Regional and National levels.
- B.** All fees and forms required for State Presidents Cup registration must be submitted to the CYS office on or before the close of business on the due date specified on application documents.
- C.** At every Presidents Cup match each team must have valid player passes for all players listed on the roster. Coaches must also have valid passes at every cup match.

V. PROCEDURES OF THE COMPETITION

A. VENUE:

In State Presidents Cup Competition, pairings, sites and format of play shall be determined by the Presidents Cup Committee of CYS.

B. FORMAT:

Teams in each age group will be seeded into flights. The number of flights shall be determined by the number of teams entered.

C. FLIGHTING:

Structure of the competition shall be as follows:

2-7	Teams	1 Flight	Round Robin
8-10	Teams	2 Flights	Semi and Final
11-15	Teams	3 Flights	Semi and Final
16-19	Teams	4 Flights	Quarter, Semi and Final
20 plus	Teams	5 or more flights	Quarter, Semi and Final

D. SEEDING OF FLIGHTS

1. In each gender/age category seeding will be conducted according to the following order of criteria:
2. Previous year champion and finalist in Presidents Cup, first and second seed.
Previous season league standings.

E. The State Presidents Cup Referee Assignor shall appoint the referees for all Presidents Cup Competition matches. Every effort will be made to supply (3) three referees. However, club lines shall be used in extreme situations.

F. NO SHOWS:

1. Any Presidents Cup team failing to appear for a single scheduled cup match without the prior approval of the Presidents Cup Committee will be assessed a forfeit, and the Presidents Cup Committee shall review the circumstances of the no show for possible disciplinary review and/or a fine.
2. Any Presidents Cup team failing to appear for two or more of its scheduled Presidents Cup matches will be eliminated from the competition, and all game results involving that team will be voided from the standings, whether earned or lost by competition or forfeiture. Should the CYS Presidents Cup Committee find that the team’s “failure to appear” was willful or negligent, the coach and/or club officials of said team would be referred for disciplinary action and fined.

G. TEAM EXPULSION:

A team removed from Cup Competition for any team fault for one or more matches shall be required to post a bond of no less than \$2000.00 in certified funds with the CYS office prior to being admitted to any future state championship competitions. The bond will only be refunded after the team has played in all Cup matches for whom it qualifies.

H. PLAYER/COACH/SPECTATOR MISCONDUCT

1. Penalties received by players/coaches in Presidents Cup Competition, be it red or yellow cards, will be served only within the context of Cup play, and will not carry over into league or tournament play. If applicable, penalties will be served in Regional/National competition or carried over to the players/coaches next cup enrollment regardless of their team affiliation.
2. Any coach rostered to more than one team in the competition who is ejected shall sit out the next two scheduled matches of the team with which the ejection was awarded.
3. If a player/coach/spectator is sent off/dismissed for misconduct, the referee will submit the game report to the Presidents Cup Commissioner. The player/coach/spectator shall be subjected to penalties described below and shall be ineligible until he or she is reinstated by cup administration. Team/Club coaches receive double the suspension described in the penalties below.

a. Serious foul play (S1)

Examples include, but are not necessarily limited to: when a player, in a violent or dangerous manner intentionally trips, holds, pushes, charges, or tackles an opponent from behind the penalty shall be: ALL AGE GROUPS- Suspend for minimum of one (1) game.

b. Violent Conduct (S2)

Examples include, but are not necessarily limited to: Striking or attempting to strike another player, team official or spectator, unlawfully entering the field of play during an altercation. ALL AGE GROUPS – Suspend for a minimum of two (2) games.

Pushing in an act of aggression, striking or attempting to strike a referee, linesperson or fourth official. ALL AGE GROUPS- Suspend for a minimum of one (1) year, unless serious injuries are inflicted then the minimum suspension period will be at least five (5) years.

c. Spits at an Opponent/other Person (S3)

Examples include, but are not necessarily limited to: spitting or other unseemly acts on or at another person. ALL AGE GROUPS – Suspend for a minimum of two (2) games.

d. Denies opponent goal or goal scoring opportunity by deliberately (S4) handling the ball. ALL AGE GROUPS – Suspend for a minimum of one (1) game.

e. Denies obvious goal scoring opportunity to an opponent moving (S5) towards the players' goal. ALL AGE GROUPS – Suspend for a minimum of one (1) game.

f. Offensive, Insulting or Abusive Language. (S6)

Examples include, but are not necessarily limited to: uttered in frustration and in the referee's opinion, loud enough to be heard. ALL AGE GROUPS – Suspend for a minimum of one (1) game. Examples include, but are not necessarily limited to: words or actions directed towards any person. ALL AGE GROUPS – Suspend for a minimum of two (2) games.

g. Second Caution: (S7) ALL AGE GROUPS – suspend for a minimum of one (1) game.

h. Miscellaneous: Any player, substitute or coach who refuses the referee's request for their name, or gives a false name, while the referee is gathering data to report an infringement of the "Laws of the Game", involving

them, shall have a minimum of one (1) game added to the suspension that would normally be levied by the Disciplinary Committee. Actions listed above are to be regarded as minimum suspensions. Coaches and assistant coaches sent off the field of play for an infringement of the “laws of the game” shall have one (1) additional game added to the suspension that would normally be levied against a player for a similar infringement.

4. Coaches listed on multiple rosters who are suspended will serve their suspension during the next scheduled games involving the team they were coaching at the time of their suspension. In a case where the coach’s red card is received in the course of a team’s last or second to last match in the competition, the coach will report to the Presidents Cup Commissioner or the Presidents Cup Commissioner’s designated representative for determination of how the suspension will be fulfilled.
5. In specific situations, the Presidents Cup Committee may place an individual on probation in addition to the suspension. The probationary period is to be served immediately following the suspension period and is intended to monitor as individual’s degree of reform. Should an individual on probation be sent off the field of play and shown the red card during the probationary period the matter shall be referred to the Cup Committee for evaluation.

I. SCORING:

Scoring will be:

11 points to beneficiary of forfeiture

7 points for a win

3 points for a tie

0 points for a loss

1 point for each goal scored to a maximum of three goals

1 point for a shut-out (unless 0-0 tie.)

J. DETERMINATION OF WILD CARD TEAMS WHEN NECESSARY:

Because of the variance in flight sizes in some Presidents Cup Divisions, the wild card team will be determined by point averaging. That is to say, the total points accumulated at the end of first round play will be divided by the number of games played. Formats for advancement games are presented as projections only. They are subject to change because no wild card team will be scheduled to play a former opponent.

K. KICK OFF AND WAITING TIME:

Kick off will be at the time shown on the tournament schedule. A 15-minute grace period will be allowed from the scheduled kick off time. If a team is not ready for play at the end of the grace period, the game is a FORFEIT.

L. THE TECHNICAL AREA (SIDELINES):

1. The technical area is a designated area for no more than four rostered technical staff members and rostered substitutes.

2. The occupants of the technical area shall be identified to the referee before the beginning of the match.

3. All members of the technical staff in the bench area must be rostered to the team occupying the bench.

4. Both teams shall be located on the same side of the field. Spectators of both teams shall occupy the opposite side of the field from the teams and coaches.

M. DURATION OF GAME:

Overtime Periods (for Quarter Finals, Semifinals, and Championship Final Games Only: No overtime periods shall be played in preliminary-round games. If a quarterfinal, semi-final or final game is tied at the end of the second regulation period, there shall be two full overtime periods. If a quarterfinal, semi-final or final game is still tied at the end of the second overtime period, the winner shall be determined by FIFA kicks from the mark.

N. TIE BREAKING PROCEDURES:

Should there be a tie at the completion of a round that determines advancement, the tie will be broken by the following order of criteria:

1. Head to head (these criteria not used if more than two teams are tied).
2. Least goals allowed
3. Most goals scored up to a maximum of six (6) per game
4. Full match with overtime and kicks from the mark if necessary.

Note: If more than two teams are tied, the sequence will be followed until a team is eliminated. The remaining teams will then restart the sequence at Point "2" above until the tie is broken.

O. PROTEST AND APPEALS:

1. To be valid and eligible for consideration, protests shall be lodged verbally with the referee and the opposing coach at the game site within five minutes after the end of the game, except protests relating to the grounds, goal posts, bars, and their appurtenances of the game must be in writing and submitted to the referee and opposing coach prior to the start of the game.
2. All protests must be made in writing within one hour after the end of the game in which the protest incident occurred, accompanied by a non-refundable \$100.00 protest fee to the Presidents Cup Commissioner or the Presidents Cup Commissioner's designated representative.
3. If these conditions are not met in full, the protest will not be considered.
4. Upon receiving a properly filed protest, the Presidents Cup Commissioner will determine the time and location of the protest hearing and shall designate the members of the ad hoc protest committee. This committee will meet in a closed meeting to make a ruling on the protest.

5. A plea of ignorance to the rules and regulations of the Presidents Cup competitions is not sufficient grounds for a protest or appeal. Violators may expect appropriate action by the CYS Presidents Cup Committee.

6. In Presidents Cup competitions at the State Association level, decisions made on protests and appeals by the CYS Presidents Cup protest and appeal authority are binding and allow the competition to proceed.

P. UNFINISHED GAMES:

A. Any game that is stopped for any cause except team fault before the end of the first half will be replayed.

B. Any match that is stopped in the second half for any reason except team fault will be considered complete.

C. A playoff round match stopped for any cause may be reviewed by the CYS Presidents Cup Committee for determination of status.

Q. RULES OF PLAY:

FIFA rules as modified by CYS will be in effect.

R. HOME TEAM DETERMINATION:

The home team is always listed first on the cup schedule. If both teams are wearing similar jerseys, the home team shall wear dark jerseys and the visiting team shall wear light colored jerseys. If the visiting team does not carry a light colored jersey, then the visiting team shall wear an alternate dark color that does not conflict with the home team's colors. Either team's goalkeeper shall change jerseys as the referee directs regardless of home/visitor status. Each team will provide a game ball for the match, subject to referee approval.

S. SUBSTITUTIONS:

Substitutions shall be unlimited except where specified otherwise in the rules and regulations for a special competition.

Substitutions may be made, with the consent of the referee, at any stoppage in play.

VI. MATTERS NOT COVERED:

Any matter not addressed in these rules or the US Youth Soccer Presidents Cup Rules will be decided by the CYS Presidents Cup Committee. Decisions in such matters will be final and binding.
